This Guidebook is written upon the agreement of FISU and the Executive Committee of the Chengdu 2021 FISU World University Games (the 'Chengdu 2021 FISU Games') based on the current COVID-19 prevention and control requirements in China and the foreseen situation during the Chengdu 2021 FISU Games. Changes may need to be made in the future, to ensure that any evolution of the COVID-19 pandemic and related regulations are fully taken into account.

# **1. PRINCIPLES**

### 1.1. Vaccination

Vaccines are proven to reduce infection with and transmission of COVID-19 and are a key tool in enabling activities to be carried out safely. It will be mandatory to be fully vaccinated at least 14 days prior to departure for China, in order to be allowed in the closed-loop management system without quarantine. Recognised vaccines are those approved by World Health Organization (WHO), relevant international organisations or relevant national/regional authorities.


Anyone not fully vaccinated will need to quarantine for 21 days upon arrival in Chengdu.

## 1.2. Closed-loop Management System

Closed-loop management is a special system to keep participants and local citizens safe by reducing unnecessary interactions while allowing participants to perform their day-to-day duties during the Chengdu 2021 FISU Games.

If you are fully vaccinated, this closed-loop management system allows you to go directly to Chengdu without undergoing compulsory 21-day quarantine.

Closed-loop management will be performed throughout your stay in Chengdu. Within the closed loop, all participants (including domestic workforce) will be subject to daily monitoring of health status and PCR tests, and can only transfer to and from designated venues and accommodation sites by dedicated vehicles. This is to ensure there is no contact with the general public or anyone outside the closed loop.



1.3. COVID-19 Liaison Officers

Every delegation taking part in the Chengdu 2021 FISU Games has to nominate their COVID-19 Liaison Officers (CLOs). FISU and the Executive Committee of the Chengdu 2021 FISU Games will conduct training on CLOs.

As part of their role, your CLO:

•Will support you in making sure that you understand the contents of this Guidebook, the importance of complying with the rules and the potential consequences (including legal consequences) of non-compliance.

·Will be in contact with you regularly with NUSF's communication channels.

·Will help you complete all necessary documentation before you travel to China.

Ask them if you have any questions or concerns, and they will reply to all questions and concerns related to this Guidebook.

# 1.4. Testing, Tracing and Isolation

Download the 'Chengdu 2021' App, monitor and track your health status daily, and upload your valid vaccination certificate 14 days before your departure for China (see '3.1. Smartphone Apps and Websites').

Get two PCR tests and provide proof of negative results before your departure for China.

#### **PRINCIPLES**

Inbound participants who enter the Chinese mainland via the Chengdu Shuangliu International Airport will get another PCR test at the airport. Inbound participants who enter the Chinese mainland via other cities need to comply with the local quarantine policies, and can participate in the Chengdu 2021 FISU Games only after required quarantine. Participants in the Chinese Mainland will enter the closed loop with a negative PCR test result within 72 hours.

Accept daily PCR tests during the Chengdu 2021 FISU Games.

Get a further test if you experience any symptoms or are told to do so (e.g., if you are identified as a close contact) by the Chinese health authorities. If your test is positive, you will need to isolate.

Close contacts are considered those who have direct body contact or have contact within one metre distance for 15 minutes or longer, without properly wearing a mask, with someone who has tested positive for COVID-19 within the two days before symptoms onset or within the two days before the asymptomatic infected person is sampled and found positive.

# 1.5. Minimise Physical Interaction

COVID-19 is transmitted through respiratory droplets and aerosols in our breath exhaled by coughing, sneezing, talking, shouting or singing. A person can be infected when aerosols or droplets containing the virus are inhaled or come directly into contact with the eyes, nose, or mouth.

The risks of getting COVID-19 are higher in crowded and inadequately ventilated spaces, and when you spend time together with infected people in close proximity.

Therefore, it's important to be vaccinated, minimise physical interaction, wear a mask and avoid spaces that are enclosed, crowded or involve close contact.

·Minimise physical interactions with others within 14 days before you travel to China.

·Avoid physical contact, including hugs and handshakes.

·Keep physical distance of at least one metre from others.

·Avoid enclosed spaces and crowds and social gatherings where possible.

·Use dedicated vehicles.

·Only carry out duties relevant to your role in the closed loop.

## 1.6. Keep Good Hygiene

You may become infected when touching your eyes, nose or mouth after touching surfaces or objects that have been contaminated by the virus. Therefore, you must remember the basics of good hygiene: regularly and thoroughly clean your hands, disinfect surfaces or objects, and avoid touching your faces. Please prepare enough masks for your stay in China. And wear a face mask in line with the WHO guidelines:

•Properly wear a face mask without an exhalation valve (KN95, N95, FFP2, or medical masks recognised in your country/region of residence with equivalent standard of protection) at all times except when training, competing, eating, drinking or when alone.

·Make sure your mask completely covers your nose, mouth and chin.

•Replace your mask every four hours, or as soon as they become deformed, damp or dirty.

·Clean your hands before you put your mask on, as well as before and after you take it off, and after you touch it at any time.

•Put the used mask into a trash bin; every day either wash your mask if it's a fabric one, or dispose of it in a trash bin.

Please practise thorough hygiene measures as outlined, throughout your stay in China:

·Wash your hands regularly and thoroughly for at least 20 seconds, ideally using liquid soap and flowing water. Otherwise, use hand sanitiser.

·Cheer for athletes by clapping instead of singing or chanting.

·Avoid sharing items where possible, or disinfect them.

·Keep rooms you are staying well ventilated regularly.

# 1.7. Observe Prevention and Control Policies

It is the responsibility of FISU, the Executive Committee of the Chengdu 2021 FISU Games and all delegations to ensure participants' compliance with COVID-19 prevention and control policies.

Athletes and delegation officials will be subject to sanctions if they violate COVID-19 prevention and control policies.

Athletes and delegation officials are required to check and report health status daily, submit valid vaccination certificates, and PCR and IgM antibody test certificates before entry; take daily PCR tests from the date of arrival in Chengdu to the date of departure from Chengdu.

The primary responsibility for personal health and overall epidemic control lies in every participant. Therefore, all athletes and delegation officials are required to fully observe the COVID-19 prevention and control policies.

# **2. YOUR JOURNEY**

## 2.1. Before Your Travel

Before you travel, make sure you have understood the Guidebook and the importance of complying with the rules contained herein. See '3.4. Non-Compliance and Consequences'. If you have any question, contact the NUSF of your country/region of residence or your CLO as soon as possible.

The rules for epidemic prevention and control in connection with entry to China are formulated in accordance with the policies of the Chengdu 2021 FISU Games issued by the Chinese government. These rules also apply from 14 days before your travel (including pre-departure prevention and control), as well as throughout your journey to China.

#### 2.1.1. Notes before your travel

2.1.1.1. Support from your CLO before your travel

Your CLO will support you in making sure you understand the Guidebook and comply with the rules herein.

Your CLO will help you download, install, register and log in the 'Chengdu 2021' App to complete identity authentication.

If you test positive for COVID-19 before your departure, please inform your CLO immediately. If you have any questions or concerns, please contact your CLO promptly.

#### 2.1.1.2. Insurance for travelling to and staying in Chengdu

As per FISU's requirements, the Executive Committee of the Chengdu 2021 FISU Games has contracted Death, Disablement, Medical Assistance and Repatriation Insurance for athletes, delegation officials, technical officials and FISU Family. The insurance will only cover incidents occurring during their stay in Chengdu, including death, injury, disability, medical treatment, rescue, and repatriation. Given its coverage and period of the insurance,

the Executive Committee of the Chengdu 2021 FISU Games recommends that they purchase additional personal accident and health insurance to cover the costs of medical services and related accidents that may arise beyond the period of insurance and coverage.

The Executive Committee of the Chengdu 2021 FISU Games will set up an Insurance Information Desk in the Residential Zone of the FISU Games Village and designate insurance professionals to deliver consultation services.

#### 2.1.1.3. Get a visa before departure for China

You are required to apply for a visa through the Chinese Embassy/Consulate in your country of residence or an otherwise competent institution authorised by the Ministry of Foreign Affairs of the People's Republic of China, except you are exempted from visa restrictions.

You will receive a Confirmation Letter for applying for your visa issued by the Executive Committee of the Chengdu 2021 FISU Games after you complete the registration via the FISU Online Accreditation System (OAS).

Once you receive the Confirmation Letter, please start to apply for a visa through the Chinese Embassy/Consulate in your country of residence or an otherwise competent institution authorised by the Ministry of Foreign Affairs of the People's Republic of China – at least 10 working days before departure. For detailed materials required, please refer to the website of the Chinese Embassy/Consulate in your country of residence.

Please make sure that you have obtained a visa before your departure for China.

#### 2.1.1.4. Green QR Code (Health Declaration Certificate)

Take two PCR tests before your departure for China. The first test should be performed within 96 hours of your departure, by a testing agency approved by your country/region of residence. The second test should be performed within 72 hours of your departure, by a testing agency approved by the Chinese Embassy/Consulate. The two tests should have a minimum interval of 24 hours. All the hours are measured by the take-off time of your final leg of flight to China. Upload the PCR test results at https://hrhk.cs.mfa.gov.cn/H5/ to obtain your Green QR Code. Step 1: Click 'Register now' if you use the Health Declaration Certificate system for the first time.



Step 2: Enter your email address and click 'Get the verification code'.


Step 3: Check your email inbox and enter the 'Email verification code'. If you do not receive the code in your inbox, please check the spam folder.

Step 4: Check the 'Terms and conditions' box, and click 'The next step'.




Step 5: Select 'Foreign Passengers apply for Health Declaration Form', and answer questions concerning safety.

Step 6: Select 'Apply for health declaration form'.



Step 7: Fill in the form with your personal information (including contact details, flight itinerary and health status) and upload photo files of the required documents. These include the personal information page of your valid passport, proof of residence (if any), visa, the Confirmation Letter, vaccination certificate, and negative test results. If you have previously contracted COVID-19, additional documents will be required (see '2.1.2.6 Additional Testing Requirements'). Please note that all documents need to be uploaded as image files (in jpg/jpeg format) less than 10 MB in size.



#### Step 8: Click 'Submit'.

The Chinese Embassy/Consulate will process your application as soon as possible.

Once your application has been approved, your QR code will change from orange to green. Keep the browser and the webpage dialog window open, do not close the app, and refresh the page to obtain your Green QR Code.

Take a screenshot of the Green QR Code and the vaccination information submission page on your mobile phone to show at the check-in counter at the departure airport (you may also print them out in full colour as a backup copy). And be ready to show the screenshot of the vaccination information submission page upon arrival.

Note: You may also be asked to login to show the real-time QR code at the check-in counter.

#### 2.1.1.5. Air travel to China

Participants with Chinese visa, the Green QR code and the China Customs Health Declaration QR Code may come to China by international charter, temporary or commercial flights.

The first point of entry to the Chinese mainland must be the Chengdu Shuangliu International Airport if you avoid quarantine.

Commercial flights can be booked following the same procedure as normal flights.

Given the international travel and air-ground services restricted by the COVID-19 pandemic, international transit points will be set up in some airport hubs to facilitate the international charter flights to Chengdu during the Chengdu 2021 FISU Games. For more information, please refer to the Games-time Flight Booking Guide of the Chengdu 2021 FISU World University Games (to be published in late April 2022).

Participants can book their flights according to the Games-time Flight Booking Guide of the Chengdu 2021 FISU World University Games, or organise their own charter flights, or share the charter flights with other delegations through their chosen airline. If they organise charter flights through their chosen airline, they should provide confirmed flight details to the liaison (fal@2021chengdu.com) of the Executive Committee of the Chengdu 2021 FISU Games.

Anyone with a body temperature higher than 37.3°C (inclusive) or other COVID-19 symptoms will be rejected from boarding.

2.1.1.6. The Executive Committee of the Chengdu 2021 FISU Games and the Civil Aviation Administration of China ('CAAC') encourage Chinese and foreign airlines with operating permits to operate international charter and temporary flights to and from the Chengdu Shuangliu International Airport.

The Executive Committee of the Chengdu 2021 FISU Games will assist such airlines in completing corresponding approval procedures for such international charter and temporary flights. Please contact the liaison (fal@2021chengdu.com) of the Executive Committee of the Chengdu 2021 FISU Games if you need to negotiate with CAAC.

You are advised to book your flight as early as possible, as it may take at least 20 working days for relevant authorities to approve the international charter and temporary flights.

2.1.1.7. Client groups should submit their arrival and departure information via the FISU OAS travel information form within the specified time.

You are required to submit your arrival and departure information through the OAS travel information form from 27 February to 26 May 2022.

For any change, please contact your CLO and the liaison for delegation services (email to be confirmed) of the Executive Committee of the Chengdu 2021 FISU Games to modify and update your travel information at least 48 hours before departure for China. Standardised arrival and departure services may not be guaranteed for any information change within 48 hours before your departure.

The arrival and departure information must include flight number/train number, time for arrival and departure, as well as number and size of standard luggage and oversized luggage

#### 2.1.2. Requirements and instructions for pre-departure testing, tracing and isolation

2.1.2.1. Download, register and log in the 'Chengdu 2021' App to complete the identity authentication 14 days before departure for China. For more information, see '3.1. Smartphone Apps and Websites'.

2.1.2.2 Upload a valid vaccination certificate (if any) to the 'Health Monitoring' module of the 'Chengdu 2021' App.

2.1.2.3 Self-monitor your health status daily 14 days before departure for China •Self-monitor your body temperature and health status daily for any COVID-19 symptoms, and report your health status via the 'Health Monitoring' module of the 'Chengdu 2021' App. •If you have any difficulty with thermoregulation, please provide medical documentation to your CLO before you start self-monitoring your health status. Your CLO will inform the

Executive Committee of the Chengdu 2021 FISU Games accordingly.

•Take the initiative to monitor your health status daily for any other COVID-19 symptoms; see WHO guidelines on COVID-19 symptoms.

2.1.2.4. If you experience any symptoms of COVID-19 within the 14 days before departure for China

•Consult with a doctor or healthcare professionals. •Inform your CLO.

2.1.2.5. All participants should take necessary COVID-19 tests required to enter China Take two PCR tests before your departure for China. For details, please refer to '2.1.1.4. Green QR Code'.

Please go to the website of the Chinese Embassy/Consulate for the list of approved testing providers. If there is no such list on the website, please follow the instructions on the website for a qualified testing facility.

If either of the two tests is positive, please cancel your planned trip to China.

2.1.2.6. Additional testing requirements

If you are fully vaccinated and have previously contracted COVID-19, you should submit materials to the Executive Committee of the Chengdu 2021 FISU Games (email to be determined) for review, at least eight working days before your planned departure.

If your recovery is longer than 30 days, you can just submit the medical/laboratory certificates (in English original/translated version) with the dates of infection and recovery, and the application form (to be further provided) from the CLO to the Executive Committee of the Chengdu 2021 FISU Games.

If your recovery is shorter than 30 days, you should submit the following:

 $\cdot$ Medical/Laboratory certificates (in English original/translated version) with the dates of infection and recovery.

·An application form from the CLO (to be further provided).

•Two negative PCR test results taken with a minimum 24-hour interval at any time after the recovery.

The Executive Committee of the Chengdu 2021 FISU Games will review the submitted documents within five working days, and inform you whether you are eligible for travel to China.

You will be eligible to travel if you provide all documents and information as outlined above. If your documents are incomplete, the Executive Committee of the Chengdu 2021 FISU Games

will request additional information.

It is important that you submit your documents as early as possible to allow for additional requests from the Executive Committee of the Chengdu 2021 FISU Games, if required.

Upon approval, the Executive Committee of the Chengdu 2021 FISU Games will return the application form signed and stamped.

If you are eligible for travel, take two PCR tests before your departure. For details, please refer to '2.1.1.4. Green QR Code'.

#### If you are not fully vaccinated and have not previously contracted COVID-19:

Take two PCR tests before your departure. For details, please refer to '2.1.1.4. Green QR Code'.

Take an IgM antibody test within 72 hours of your departure by a testing provider approved by the Chinese Embassy/Consulate, as per one of the PCR tests. If you are travelling indirectly, the hours are measured by the take-off time of your final leg of flight to China.

### If you are not fully vaccinated but have previously contracted COVID-19, you should submit materials to the Executive Committee of the Chengdu 2021 FISU Games for review, at least eight working days before your planned departure.

If your recovery is longer than 30 days, you can just submit the medical/laboratory certificates (in English original/translated version) with the dates of infection and recovery, and the application form from the CLO to the Executive Committee of the Chengdu 2021 FISU Games. If your recovery is shorter than 30 days, you should submit the following:

 $\cdot$ Medical/Laboratory certificates (in English original/translated version) with the dates of infection and recovery.

·An application form from the CLO.

•Two negative PCR test results taken with a minimum 24-hour interval at any time after the recovery.

•One IgM antibody test within 72 hours of your departure by a testing provider approved by the Chinese Embassy/Consulate, as per one of the PCR tests. If you are travelling indirectly, the hours are measured by the take-off time of your final leg of flight to China.

The Executive Committee of the Chengdu 2021 FISU Games will review the submitted documents within five working days, and inform you whether you are eligible for travel to China.

You will be eligible to travel if you provide all documents and information as outlined above. If your documents are incomplete, the Executive Committee of the Chengdu 2021 FISU Games will request additional information.

It is important that you submit your documents as early as possible to allow for additional requests from the Executive Committee of the Chengdu 2021 FISU Games, if required.

Upon approval, the Executive Committee of the Chengdu 2021 FISU Games will return the application form signed and stamped.

If you are eligible for travel, take two PCR tests before your departure. For details, please refer to '2.1.1.4. Green QR Code'.

2.1.2.7. If either of your PCR tests is positive, please cancel your planned trip to China. Contact your CLO, who will record your symptoms, test results and close contacts, as well as inform the Executive Committee of the Chengdu 2021 FISU Games and agree on next steps.

2.1.2.8. You will need to present two sets of QR codes required by the Chinese governments for travel to China: the Green QR Code (Health Declaration Certificate) and the China Customs Health Declaration QR Code.

#### (1) For the Green QR Code, please refer to 2.1.1.4.

#### (2) For the China Customs Health Declaration QR Code:

Fill in the online China Customs Health Declaration form (available at https://health. customsapp.com) at a maximum of 24 hours before your arrival in China. Once this form is completed, you will receive your China Customs Health Declaration QR Code.

Provide your seat number to complete the form. If you do not have your seat number on your ticket reservation, you may need to do this once you check in. For more information, see '3.1.

Ask your CLO if you have any problem in receiving your Green QR Code or China Customs Health Declaration QR Code.

2.1.2.9. If you are identified as a close contact in your country/region of residence, please bring relevant medical documents (in English original/translated version) including:

•Two PCR test results taken within 96 hours of departure.

·Vaccination status (number of doses, date of vaccination[s] and vaccine type/brand).

•Prior history of COVID-19 tests (test result, date of test and test type: PCR/antigen/other).

•Presence of antibodies (date of antibody test, result, testing platform for information on viral target, titre/quantitative result, if applicable).

# 2.2. Entering China

#### 2.2.1. Overview

Upon arrival in China, you must observe the instructions of the Chinese authorities and the following policies for COVID-19 prevention and control at the airport and for your onward journey.

You must follow physical distancing and good hygiene practices throughout your time in China.

If you are tested positive for COVID-19 on arrival or experience any symptoms, immediately inform your CLO.

2.2.2. Requirements and instructions for testing, tracing and isolation for entering China

2.2.2.1. Upon arrival at the Chengdu Shuangliu International Airport, customs officers will board the aircraft for inspection. According to relevant airline requirements, temperature might be checked on board. Any participant who has reported COVID-19 symptoms during the flight will be guided to get off the aircraft for medical screening.

2.2.2.2. Once you have departed the aircraft, you need to cooperate with customs staff in your health declaration verification and body temperature checking.

Be ready to show the following:

·China Customs Health Declaration QR Code.

·Valid passport or other travel document.

·Screenshot of the vaccination information submission.

Initial temperature check upon arrival will be conducted with an infrared thermometer. If your temperature is higher than 37.3°C (inclusive), it will be checked again with a mercury thermometer after a short break.

If you record a high temperature (37.3°C or higher) again, or if you have any other COVID-19 symptoms, you will undergo medical screening. You will be guided by customs staff to a separate area in the airport terminal for PCR test. If required due to symptoms, you will be transferred to the Polyclinic in the FISU Games Village by a dedicated vehicle for medical screening.

2.2.2.3. If your health declaration and temperature are normal, you will be asked to get a PCR test.

You will get a PCR test in a special customs inspection area for the Chengdu 2021 FISU Games.

Trained customs staff will take your oropharyngeal and nasopharyngeal swab samples at the special sampling points for the Chengdu 2021 FISU Games.

If you fail to provide a screenshot of the vaccination information submission page (see '2.1.1.4. Green QR Code'), you will need to quarantine for 21 days.

#### 2.2.2.4. Complete immigration inspection

You need to show your passport, visa, and arrival card (to be obtained on the aircraft or at the immigration inspection). Your fingerprint and mug shots will also be captured for verification. If they are consistent, your document will be stamped. Then you can pass the inspection point.

2.2.2.5. Participants will take dedicated vehicles to official accommodation sites guided by relevant staff and signage.

2.2.2.6. You will be transferred to your designated accommodation site and will be required to wait in your room until you receive your PCR test results. Your PCR test results will be processed as efficiently as possible. Meanwhile, room-temperature meal bags will be provided to your room while awaiting your testing results.

If your test results are suspected positive or positive, your CLO will inform you, and you will be taken by a dedicated vehicle to the Polyclinic to collect nasopharyngeal swabs for confirmatory test. For more information, see '2.3.2.7. Confirmatory tests'.

If you are confirmed positive by the confirmatory test, you will be taken by a dedicated vehicle to a designated hospital for quarantine and treatment. Your CLO will record your symptoms, test results and help identify close contacts.

2.2.2.7. If you are identified as a close contact of a confirmed case on your aircraft, your CLO will inform you within 24 hours of your arrival and explain the next steps, including testing. A close contact on a flight is a person who:

·Seated in the same row as or within two rows before/behind the confirmed case.

•Had face-to-face contact with the confirmed case for over 15 minutes, without wearing a KN95/N95/FFP2 mask (or mask of an equivalent standard of protection, recognised in your country/region of residence).

## 2.3. Games-time

#### 2.3.1. Overview

Keep physical distancing and practise good hygiene throughout your stay in China to ensure your own health and safety, and that of all participants and local citizens. Measures are hereinafter laid out and summarised in the Principles. The Executive Committee of the Chengdu 2021 FISU Games will monitor your behaviours to ensure compliance.

#### Support from your CLO during the Chengdu 2021 FISU Games

Your CLO can help you upload monitoring results of your health status daily. Your CLO will help you ensure that you follow the correct procedures for daily PCR test, and inform you if a suspected positive or positive test result is returned. If you have a confirmed positive test or show any symptoms of COVID-19, immediately inform your CLO, who will take you through the next steps. If you're unclear about any of the rules contained herein, ask your CLO.

#### Competition continuity and sport-specific countermeasures

Policies regarding the competition continuity when a positive case is confirmed shall be further developed by FISU, IFs and the Executive Committee of the Chengdu 2021 FISU Games.

#### 2.3.2. Requirements and instructions for Games-time testing, tracing and isolation

2.3.2.1. You shall proactively check your personal health status every day (body temperature and any other COVID-19 symptoms) and report the results via the 'Health Monitoring' module of the 'Chengdu 2021' App. For more information, see '3.1. Smartphone Apps and Websites'. We recommend that you bring your own thermometer to continue to monitor your health status daily, and that you check your body temperature at the same time every day to ensure the consistency of your health information.

2.3.2.2. You should show the QR code on the 'Health Monitoring' module of the 'Chengdu 2021' App for daily PCR test (see '3.1. Smartphone Apps and Websites' for more information) (Information to be further released).

2.3.2.3. Your temperature shall be checked with an infrared thermometer before entering training or competition venues.

If your temperature is 37.3°C or higher, it will be checked again after a short break, using a mercury thermometer.

If you record a high temperature again, you will be transferred to the Polyclinic in the FISU Games Village for medical screening.

You will be able to enter the venues as long as:

·You have no other symptoms.

·Both medical staff on-site and your team doctor agree that you can perform your training/ competition/duty without the risk of endangering your health or that of others.

·You are aware of your health status and any possible consequences.

 $\cdot$ You follow the additional countermeasures applicable to close contacts until your temperature returns to normal without other symptoms, and you receive a negative PCR test from a sample taken after the high temperature was recorded. For more information on such countermeasures for close contacts, see 2.3.2.10.

·If you have persistent high temperature or show other symptoms, your team doctor will be consulted, and you may be transferred to a dedicated hospital. You can also request to go to a dedicated hospital.

2.3.2.4. If you show any other COVID-19 symptoms (see WHO guidelines on COVID-19 symptoms):

·You shall contact your CLO immediately for next steps.

·You will be taken to a designated room at the venue or accommodation site for medical screening and consultation with medical staff.

#### 2.3.2.5. Screening test

In addition to tests taken before your departure for and upon arrival in China, you will take daily PCR tests for free to minimise the risk of undetected positive cases that could transmit the virus.

Medical staff will perform testing using oropharyngeal swabs at the sampling sites, including the FISU Games Village and other accommodation sites.

The Executive Committee of Chengdu 2021 FISU Games is developing a sampling site list and determining the opening hours of the sampling sites, and will share them with all NUSFs and CLOs when available.

You can be tested at your selected time during the opening hours of the sampling sites, and moreover, you do not need to make a reservation. You should plan your test reasonably so that you receive your results at a time that does not interrupt your training or competition.

If you need to be tested beyond the regular opening hours due to competition, training or other operational needs, you shall inform your CLO in advance so that the Executive Committee of

Chengdu 2021 FISU Games can arrange an alternative site and/or hours for you. If you fail to take your PCR test daily, you will not be allowed to leave your room next day.

#### 2.3.2.6. Obtaining the results

If your test results are suspected positive or positive, your CLO will receive a notification and inform you.

If you do not receive a notification from your CLO, your test results are negative.

#### 2.3.2.7. Confirmatory tests

If your test results are suspected positive or positive, you will need to take a confirmatory nasopharyngeal swab PCR test, accompanied by designated staff.

If you are experiencing symptoms, you shall tell the aforementioned staff and your CLO and take a dedicated vehicle to have the confirmatory test at the Polyclinic. You shall wait for your results as requested by the Polyclinic.

On-site medical staff will inform you and your CLO of your results. You will be told about next steps including isolation, if you are confirmed positive.

Together with your CLO/team doctor, the on-site medical staff will confirm whether you are symptomatic or asymptomatic.

#### If you have a confirmed positive test:

You will not be allowed to compete or continue your duty.

You shall take a dedicated vehicle to a designated hospital for isolation (treatment).

#### 2.3.2.8. Isolation (treatment)

There will be English-speaking personnel at the facilities who will monitor your health status. Three meals will be provided in the hospital every day, with diversified food options to cater for various dietary needs. Free WiFi will be available and you will be able to keep in touch with your CLO and sport team.

Quarantine wards are subject to closed management. Therefore, you cannot have caregivers or visitors, but hand-over of items (other than those affecting treatment) is allowed.

Athletes may request indoor training equipment, and such demand will be met where available. You shall not go outside.

Mental health support will be available.

#### 2.3.2.9. Being released from isolation

You will be released from isolation in accordance with the discharge guidelines established by the Chinese health authorities.

#### COVID-19 confirmed case:

·Your body temperature returns to normal for three consecutive days.

·Your respiratory symptoms improve significantly.

·Your lung imaging shows significant improvement.

·You have two consecutive negative results of PCR tests at a minimum interval of 24 hours.

·You display no other COVID-19 symptoms.

You will be released from isolation when all the above conditions are met.

#### Asymptomatic:

If you are asymptomatic, you will be tested every day 24 hours after your last test. You will be released from isolation once you have two consecutive negative results of PCR tests at a minimum interval of 24 hours, and experience no other COVID-19 symptoms.

#### 2.3.2.10. Close contacts

If there is any confirmed case, his/her close contacts will be identified through the following steps:

•CLOs will assist the confirmed case in listing the activities participated in and places visited from the two days before symptom onset (if symptomatic), or the two days before the sample was collected (if asymptomatic).

•The Chinese health authorities will work closely with the public health teams in the venues to further help identify close contacts. Key information includes: PCR test results; date of symptom onset (if symptomatic); date of PCR test sampling; possible source of infection, list of potential close contacts; list of activities participated in and places visited after infection and before isolation.

Your CLO will assist the Chinese health authorities and the Executive Committee of the Chengdu 2021 FISU Games in determining further steps, such as the disinfection of specific areas.

The process to identify close contacts will as efficient as possible. However, if you know you have spent time with someone who has tested positive for COVID-19 in close proximity, you must minimise your interaction with others whenever possible until the identification of close contact process is completed.

If you are not identified as a close contact, you will be able to return to your role without any restriction.

If you are identified as a close contact, your CLO will inform you the next steps including testing within 24 hours.

If you are identified as a close contact, the Executive Committee of the Chengdu 2021 FISU Games will provide you with a single room in the FISU Games Village. You can continue to perform your duty if you meet the following conditions:

·Reside in the provided single room.

·Take dedicated vehicles between your accommodation site and venues.

·Dine alone.

·Wear a face mask at all times.

·Limit your physical interaction with others unless necessary to perform your duty or for receiving daily care.

·Keep a distance of two metres from others.

•Check your temperature twice a day and record your highest temperature of the two checks in the 'Health Monitoring' module.

•Respond to daily health enquiries by the health authorities' medical staff who will administer your PCR tests.

·Have PCR tests every 12 hours for seven consecutive days.

•Medical staff will come to your room to carry out PCR tests with nasopharyngeal swabs. If for medical reasons, you cannot take nasopharyngeal swabs, then take oropharyngeal swabs instead.

·If all your test results are negative for seven days, the testing frequency will revert to normal.

If you have an upcoming competition, in addition to meeting the above conditions, you are also required to meet the following conditions for training or competition:

•Take an additional PCR test six hours before your competition. The additional test will be included in the routine PCR test being taken every 12 hours. You do not need to take more than two tests per day.

•Your training and competition schedules will also be taken into account for the PCR test before your competition. If taking a test six hours before competition will interrupt your preparation, including your sleep or training, an alternative time of the test will be provided. Contact your CLO if you think this will be the case.

·If each result is negative, you will be allowed to participate in competitions.

•Participation in pre-competition training and training sessions during the competition will be allowed as long as your test results are negative.

•Training in indoor fitness facilities will not be permitted. However, the Executive Committee of the Chengdu 2021 FISU Games will make every effort to provide athletes with fitness equipment in their rooms. If this is not possible, a dedicated space for training will be made available.

#### 2.3.3. Requirements and instructions for minimising physical interaction

·Limit your contact with other people whenever possible. Minimise physical interactions such as hugs, high-fives and handshakes.

Keep a distance of at least two metres from other participants.

•There may be times when the distance between athletes and others is less than two metres, for example, on the Field of Play and in preparation areas. The Executive Committee of the Chengdu 2021 FISU Games, FISU and IFs will take necessary measures to prevent and control COVID-19.

·Avoid crowd and poorly ventilated spaces wherever possible.

·Avoid staying in any space for too long time if unnecessary. Refrain from talking in poorly ventilated spaces, such as elevators.

The restriction of keeping two metres' distance from others will be waived for those in need of

additional support.

•Wear a face mask (KN95, N95, FFP2, or medical masks recognised in your country/region of residence with equivalent standard of protection) and gloves at all times when lending a helping hand to others.

·If you cannot wear a mask due to medical reasons, please ask your CLO to help you apply for wearing a face shield with a special sticker instead of wearing a mask.

 $\cdot$ Once aid has been given, sanitise your hands and go back to maintaining a physical distance of at least two metres from others.

# Requirements and instructions for minimising physical interactions during transportation services:

The Executive Committee of the Chengdu 2021 FISU Games will provide transportation services from six days prior to the Opening Ceremony to three days after the Closing Ceremony of the Chengdu 2021 FISU Games (i.e., 20 June to 10 July 2022).

Dedicated vehicles will be provided for athletes and delegation officials for arrival and departure, as well as transferring to and from accommodation sites and competition (working) venues.

Use of public transportation is not permitted. You will only be allowed to take dedicated vehicles. You cannot travel to destinations outside the closed loop.

Participants can only use vehicles provided by the Executive Committee of the Chengdu 2021

FISU Games, with the exception of temporarily imported special vehicles such as OB vans.

For designated vehicles with drivers, no one other than the assigned driver is allowed to drive the vehicle.

Dedicated vehicles are only allowed to travel to venues within the closed loop.

•Socially-distanced seating is required for passengers for competition and training of individual and team events (occupancy shall not exceed 50 percent).

·Partitions will be installed between the driver and passengers.

·Vehicles will be ventilated constantly through air conditioning.

·Drivers and passengers will wear face masks throughout the journey.

# Requirements and instructions for minimising physical interactions in the FISU Games Village:

The FISU Games Village will:

Officially open: 10:00, 20 June 2022

Officially close: 10:00, 10 July 2022

All athletes and delegation officials can reside in the FISU Games Village from the opening to the closing dates.

The FISU Games Village access is restricted as follows:

Only accredited participants with the FISU Games Village entitlement will be granted access. The FISU Games Village consists of the Residential Zone, International Zone, Operational

Zone, and Transportation Zone. FISU and the Executive Committee of the Chengdu 2021 FISU Games define four types of access rights in the FISU Games Village: 'V', 'I', '—', and 'blank'. All accredited participants in the FISU Games Village shall move within zones with authorised access accordingly.

No guest pass will be issued except for those with operational reasons, which will be subject to prior consent of the Executive Committee of the Chengdu 2021 FISU Games and FISU. For delegations:

·You should stay within your allocated apartment buildings in the FISU Games Village. Do not go to other apartment buildings, if unnecessary.

For the Executive Committee of the Chengdu 2021 FISU Games:

·We will provide single rooms to accommodate the close contacts.

We will encourage digital ways of working, and try to avoid the use of paper documents.

We will install partitions on the dining tables and food serving tables to reduce interactions.

·We will limit the number of concurrent users of the self-service laundry, Fitness Centre and Religious Centre.

# Requirements and instructions for minimising physical interaction during cultural activities

Cultural activities will be carried out in dedicated areas.

Please follow staff instructions when entering these areas, and disinfect the equipment and facilities before and after use.

Minimise physical interactions whenever possible, and keep a safe social distance.

No gathering if unnecessary, and wear a mask at all times.

#### Requirements and instructions for minimising physical interaction at venues

You will have access to venues according to your accreditation entitlements. Venues will operate under the closed-loop management system.

Additional COVID-19 prevention and control measures will be implemented for the Opening and Closing Ceremonies and Medal Ceremonies, including directions on mask wearing during national anthem playing and singing, photographing on the award podiums, social distancing, disinfection of spaces, etc. Detailed information will be provided by your NUSF closer to the Chengdu 2021 FISU Games.

#### **Spectating Policies**

You will be able to get into the venue through a dedicated passage with an accreditation card or reserved ticket, and enjoy the competition in the spectating-athlete tribune as long as you abide by the COVID-19 prevention and control policies. Specific policies are as follows:

 $\cdot$ For prime events

Prime events refer to all team sports semi-finals and finals, as well as individual sports finals. You will need to make a reservation to get a reserved ticket, which, together with the

accreditation card, will grant you the access to the spectating-athlete tribune. Take your seat shown on the ticket and observe the COVID-19 prevention and control policies.

 $\cdot$ For other events

You are able to enjoy the competition in the spectating-athlete tribune with your accreditation card. These seats will be open on a 'first come, first served' basis and according to the COVID-19 prevention and control policies.

You will be able to get to venues by dedicated vehicles from the FISU Games Village. Priority will be given to the athletes for competition.

# 2.4. Leaving China

#### 2.4.1. Overview

The Executive Committee of the Chengdu 2021 FISU Games recommends you to minimise the length of your stay in China.

From leaving China to arriving at your destination, you should continue to follow the Guidebook and any instruction or requirement of the Executive Committee of the Chengdu 2021 FISU Games on hygiene practices and social distancing.

#### 2.4.2. Requirements and instructions for testing, tracing and isolation

Please upload your departure information to OAS using the travel information form as early as possible. For details, please refer to '2.1. Before Your Travel'. Necessary change of departure information should be confirmed no later than 48 hours before departure.

International charter and temporary flights will be arranged based on your preferred departure dates. For more information, please see the *Games-time Flight Booking Guide of the Chengdu 2021 FISU World University Games.* 

Make sure you know the latest entry requirements for your destination country/region, as well as any country/region you will pass through in transit, or consult or check with your CLO.

If you need a PCR test result certificate for international travel, you will be able to get a hard copy (in English and Chinese) from your daily PCR test taken within 48 hours of departure.

The Executive Committee of the Chengdu 2021 FISU Games will provide you with PCR test certification. If your destination country/region requires additional certificates, please contact your CLO.

Obtain a China Customs Health Declaration QR Code within 24 hours before leaving China, following the same procedure as used to obtain that QR code before entering China. Keep a screenshot of the QR code to show at the check-in counter and when boarding your flight. For more information, see '3.1. Smartphone Apps and Websites'.

Travel to the airport by dedicated vehicles.

Follow the signage in the airport for departure procedures.

Upon arrival at your destination, follow local COVID-19 control regulations, including any need to quarantine upon arrival.

Continue to check your health status and temperature for 14 days after leaving China. If you have any COVID-19 symptoms, inform your CLO.

## 2.5. Non-Compliance and Consequences

The measures contained herein have been established based on the latest scientific achievements, expert advice and best practices from other international events. We draw to your attention that risks and impacts may not be fully eliminated and that you agree to participate in the Chengdu 2021 FISU World University Games at your own risk. We trust that these measures are proportionate to mitigate the above-mentioned risks and impacts, and we fully count on your support to comply with them.

As part of the accreditation process and according to requirements of related documents for the Chengdu 2021 FISU Games, your NUSF/NOC or similar student organisations will bring some information relating to these measures to your attention: in particular, that compliance with the rules of the Guidebook is necessary for you to be granted your accreditation and maintain it; and that, in some cases, these measures may also involve the processing of your personal data, including health-related information. In light of the above, we count on you to ensure that you have read carefully and understood the contents of the Guidebook (including any further updates thereto), and abide by the rules contained therein, as well as any further instructions that may be issued by the Chinese authorities, FISU, IFs, the Executive Committee of the Chengdu 2021 FISU Games and/or your NUSF/NOC or similar national student organisations. Your compliance with such rules and instructions is key to successfully achieve our common

objective: to ensure that the health of all the participants in the Chengdu 2021 FISU Games is protected, and that the Chengdu 2021 FISU Games are safely staged.

Non-compliance with the rules contained in the Guidebook may expose you to consequences that may have an impact on your participation in the Chengdu 2021 FISU Games, your access to Games venues and, in some cases, on your participation in competition. Failure to comply with these rules such as refusing to take a test, going to destinations beyond the access permissions of your accreditation card, or intentionally disrespecting mask wearing or safe social distancing measures, may result in disciplinary consequences. These disciplinary consequences may be imposed by FISU, IFs, the Executive Committee of the Chengdu 2021 FISU Games, your NUSF/NOC and/or other similar national student organisations in accordance with their rules and regulations.

In case of an infringement of any rules contained in the Guidebook during the Chengdu 2021

FISU Games, without limiting the consequences or sanctions imposed by your NUSF/NOC or other similar national student organisations, or other competent authorities or entities, you may be exposed to the following non-exhaustive range of potential consequences in accordance with the FISU Statutes.

·Warning(s).

·Temporary or permanent cancellation of your accreditation.

·Temporary or permanent disqualification or exclusion from the Chengdu 2021 FISU Games.

·Disqualification.

·Financial sanctions.

Your NUSFs/NOCs or other similar national student organisations may have enacted regulations in connection with COVID-19, such as codes of conduct or specific rules, which may contain similar and/or additional rules to those contained in the Guidebook. For breaching any of such regulation, you will be subject to the consequences and related sanctions imposed by your NUSF/NOC or other similar national student organisations in accordance with the aforementioned regulations.

Your IFs may have enacted regulations in connection with COVID-19 for your sports/events, and therefore these regulations may be applicable to you and/or your sport team.

Kindly note that, if there are discrepancies between the regulations of your NUSFs/NOCs/IFs and the Guidebook, the latter will prevail. Part of the measures described in the Guidebook, such as those related to the entry of and departure from China, are under the jurisdiction of the Chinese authorities.

If you have questions about consequences of non-compliance with the Guidebook, you can contact your CLO, who will determine the appropriate next steps. CLOs will receive further information and support on non-compliance with the Guidebook.

# **3. APPENDICES**

# 3.1. Smartphone Apps and Websites

The following pages provide an overview of the smartphone apps and websites' functionalities and user guides. More information, including step-by-step user guides, will be available to CLOs to share with their delegations.

#### 3.1.1. Overview

The Executive Committee of the Chengdu 2021 FISU Games has developed a smartphone app 'Chengdu 2021' to facilitate participants' stay in Chengdu. This app, to be officially released on 31 March 2022, will be available in Chinese and English, and take up a storage space of about 150Mb (to be confirmed after official release). This app complies with the Information Technology - Internet Content Accessibility Technical Requirements and Conformance Testing. 'Health Monitoring' is one of the core modules of 'Chengdu 2021' App. You will be able to upload your health status daily through the 'Health Monitoring' module after you create an account and complete identity verification.

3.1.1.1. How to Use 'Chengdu 2021' App and the 'Health Monitoring' module

#### Download

This app is available from the official website of Chengdu 2021 FISU Games upon release.

You will also be able to download and install this app from Apple's App Store, or Google Play store and other APP stores (Android/HarmonyOS).

You will be able to access your account through different mobile devices.

Login

After the app is installed, please read and accept the User Agreement and Privacy Policy. Follow instructions to sign up an account with your phone number or email address (to be determined) for login.

Identity authentication

When you are logged in, click 'My Account' at the lower right corner on the homepage, and then click "Identification authentication" to complete the authentication process by using either your passport number, accreditation card number, Chinese ID number, or the number of Mainland Travel Permit for Hong Kong and Macau Residents, or Taiwan Residents.

Commitment to truthful reporting

The first time you log in to the 'Health Monitoring' module in 'Chengdu 2021' App, an option of 'Commitment to Truthful Reporting' will be displayed. You are required to confirm that the personal data submitted is accurate and valid. Click the 'Confirm' button to upload the data. COVID-19 vaccination information

Accredited persons should fill in the required information regarding their COVID-19 vaccine (including the manufacturer name of each dose and the date of vaccination) and upload the vaccination certificate on the 'Chengdu 2021' App.

Daily health status

Accredited persons should report their health status daily (including body temperature, any other symptoms and any medical or medication records) and epidemiological history on the 'Chengdu 2021' App.

PCR test

Accredited persons should show the QR code on the 'Health Monitoring' module of the 'Chengdu 2021' App for daily PCR test (TBD).

#### 3.1.1.2. QR codes required for entry of China

In addition to the 'Health Monitoring' module of the 'Chengdu 2021' App, you will need to present two QR codes required by Chinese authorities for travelling to China: the Green QR Code and the China Customs Health Declaration QR Code. You can obtain them by filling in and submitting two online forms. Due to data protection, this requires submitting some data already entered in the 'Health Monitoring' module.

You can fill in the forms on your mobile or laptop; please consider which device will make it easier to fill in the forms, capture a screenshot of each QR code, and present them if required (see 2.1.2.8).

Your organisation may have security blocks in place that stop you from accessing the forms. If you have troubles, please try different browsers, devices, or internet connections.

#### 3.1.2. Technology tips

Technology, smartphones and apps will play a large part in assuring the success of the Chengdu 2021 FISU Games. As such, please review the tips below to ensure you are fully prepared to travel to China:

Before your departure for China, check with your service provider of mobile phone to ensure: Your SIM package is allowed, unlocked and has the rights for international data and voice

roaming during you stay in China.

You have a method of monitoring and topping up your account, depending on your contract with your mobile operator, while overseas.

Your handset is compatible with the mobile network specification of China.

If you plan to buy a mobile SIM in China, you shall confirm with the mobile operator in your country/region of residence that your handset is fully unlocked and able to be used with other international SIMs (also make note of your SIM size/form factor).

Before you leave the plane and go through customs/immigration, make sure that your phone is fully charged.

Consider bringing an external battery bank, with the correct associated cables, to keep your phone charged on the go. Please note and respect all airline, country and airport rules on the transportation of external battery packs.

Make sure you pack and bring all the charging cables and power plug/adapters for your phone. It is recommended to take these in carry-on luggage, also consider bringing spares in your check-in luggage.

Consider bringing a spare mobile phone handset, just in case something happens to your primary phone during your stay in China.

Make sure you are fully familiar with the use and operation of your mobile phone before you leave, especially how to turn flight mode on and off, how to turn international roaming data on and off and how to take screenshots.

Consider the security and safety of your phone, including the use of phone cases and screen protectors appropriate to the environmental conditions.

Consider the security of any personal data you have within your phone. You may wish to seek advice from your organisation on appropriate screen locks and password manager apps that meet your organisation's guidelines and policies.

Backup your phone and all its data before you leave. Consider having an appropriate backup regime in place for critical data or photos on your phone while travelling.

Before you leave for China, you had better ensure you have enough storage space on your phone for any new apps and photos.

Have all your travel details needed for the apps/forms written down and recorded in hard copy (and kept secure) so that you can enter them into systems and apps if/when needed while in the airport and in China.

# 3.2. Personal Data Process

Some of the COVID-19 prevention and control measures in the Guidebook require collecting and processing personal data of accredited participants. This data includes basic information (such as name, date of birth, and accreditation number) and health-related data (such as body

temperature, symptoms, report of health status, and vaccination status).

This data will be collected through screening tests, smartphone apps and other IT systems before departure for China and at Games-time. It may be submitted by you, your NUSF/CLO, and/or third parties such as laboratories involved in the implementation of the COVID-19 prevention and control measures.

Personal data will be processed in accordance with applicable laws and regulations by the following entities (each for their respective operations): the Executive Committee of the Chengdu 2021 FISU Games, Chinese authorities (including the central government, local governments, and other authorities in charge of health and safety protocols), FISU and others involved in the implementation of the COVID-19 prevention and control measures, including your NUSF, IF (where applicable), and healthcare and medical service providers.

Separate notices and/or privacy policies may also be available for specific data processing activities, such as the use of the 'Health Monitoring' module of the 'Chengdu 2021' App and other mobile apps and IT systems managed by the Executive Committee of the Chengdu 2021 FISU Games or by competent Chinese authorities.

## 3.3. Key Points to Remember

For your and others' health and safety, please keep a safe social distance during your stay in China, and observe the hygienic measures required. Key points of the Guidebook are summarised in the following table for your reference.
